

Rules on letting this property


Properties can be rented if they have an energy rating from A to E.

If the property is rated F or G, it cannot be let, unless an exemption has been registered. Energy efficiency rating for this property

This property's current energy rating is C. It has the potential to be C.

Properties are given a rating from A (most efficient) to G (least efficient).

Properties are also given a score. The higher the number the lower your fuel bills are likely to be.

Primary energy use

Environmental impact of this property

This property's current environmental impact rating is C. It has the potential to be C.
